**EXTENSION AGREEMENT**

**RENEWAL FEE: \$1000.**

1. The Company agrees to extend the original agreement to lease the equipment described therein to the tribe and the tribe desires to continue to lease the equipment in accordance with the terms set forth therein except as modified herein.

4. Vendor agrees that it and its player terminal and equipment shall comply with the currently applicable version of the Tribal Internal Control Standards ("TICS") adopted by The Thlopthlocco Tribal Town Gaming Commission.

5. All other terms and conditions of the original agreement shall remain in full force and effect during the term of this agreement.
